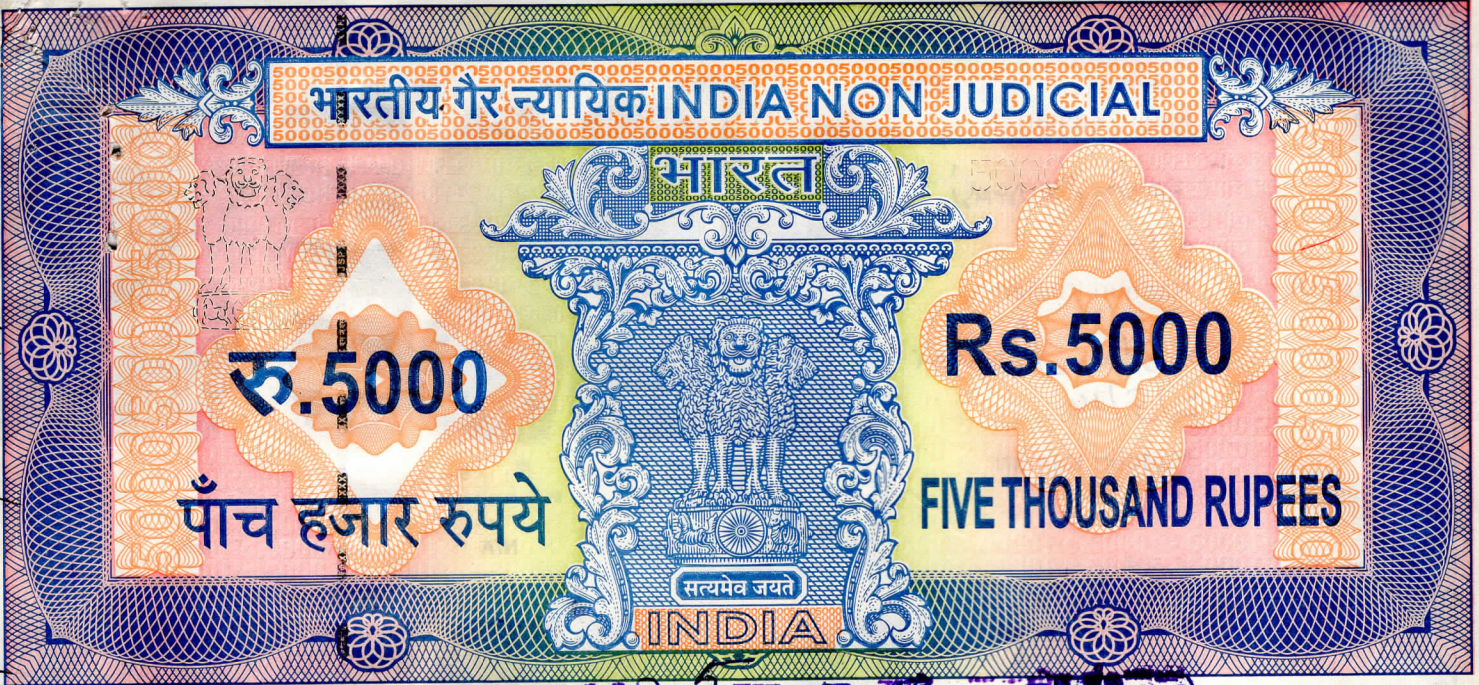

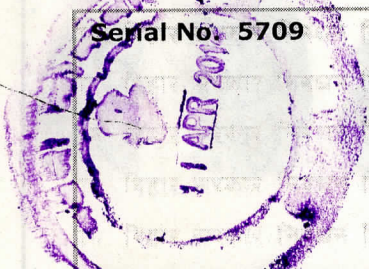



1. NAME OF THE TRUST :-

The Trust is hereby constituted as an irrevocable Trust and it shall be more particularly known as **JEEVAN JYOTI EDUCATIONAL & SOCIAL WELFARE TRUST**. The Trustees may change the name of the trust if they mutually so decided in future.

2. REGISTERED OFFICE :-

The Registered Office of the Trust shall be situated at North Mandiri, Bapu Nagar, P.S.- Budha Colony, Patna, District- Patna-1, State- Bihar.

3. DECLARATION OF THE TRUST AND ITS OBJECTIVES:-

The Trustees hereby declare that they and the survivor of the survivors of them or other Trustees or Trustees here for the time being will hold the said sum of Rs. 50,000/- (Rupees Fifty Thousand) only made over by the Settler to the Trustees as aforesaid and all gifts contributions, subscriptions, donations, request and other moneys or properties as and when the same be paid to or invested in them and the moneys, investments and properties as from time to time representing the same upon Trust to apply the same for the benefit or poor, weaker section, for improvement in environmental conditions and for the advancement of any other object of general public utility not involving the carrying on of activity for profit in the territories of India, or for Charitable purpose which tends to promote international Welfare in which India is interested and for such purpose (without restricting the generality of foregoing objects) to do all any of the following :-

1. To help, aid, assist, undertake, organize, establish and maintain schools, institutions, and colleges for imparting general, professional, vocational, industrial technical, physical, mental, arts, Science and health and promote education in Sanskrit, Hindi and English languages, to assist and provide financial assistance to the poor and needy people of the society and for any other causes of general public utility.

2. To establish and maintain centers for reflexology and Yoga therapy irrespective of caste, creed, race or religions because each and every person in this world is in search of happiness and wants live a healthy life.
3. To undertake projects, programmers and scheme relating to health education such as Medical Institutions, Dental Institutions, Pharmacy College, Hospital, Charitable Dispensaries Medical Aid Centers, Clinic, Home for Women and Children, Maternity Home, Nursing Homes, Child Welfare Centers, Sanatoriums and other Institution of similar nature and to run maintain vocational training institutions for all or any or them.
4. To do all acts deeds to provide for sanitary facilities and promotion of preventive and other measure for the health of people.
5. To establish, run and maintain Dharmshalas, Rest House, Poor Houses or any other such Charitable institutions for the benefits of all classes at any suitable place or places.
6. To help, aid, assist, undertake, organize, establish and maintain schools, institutions, and colleges for imparting general, vocational, industrial, technical, physical, mental arts, Science and health and promote education in Sanskrit, Hindi and English languages, to assist and provide financial assistance to the poor and needy people of the society and for any other causes of general public utility.
7. To supply drinking water on special occasions at concessional rate.
8. To do all such acts and things as may be conducive to the general well being of the society and upliftment of the social, educational, cultural or economic conditions or the masses.
9. To found, assist and support, establish and maintain libraries and reading rooms and to establish and maintain boarding house or hostels or assist such institutions.
10. To maintain, contribute to give aid to any medical, educational or social institutions or any charitable institutions with philanthropic purpose which may

11. To publish books and magazine for the development of education and upliftment of humanity and to distribute them to the public with or without charging price.

12. To open and maintain orphanages, widows homes and homes for blind and handicapped person and provide them vocational and other training or to render assistance to any such existing institutions and institutions.

13. To provide for endowments, stipends, scholarships and other allowances to deserving and needy students for promotion and encouragement or all types of education.

14. To conduct training programmes for farmers in the field of agriculture and rural development.

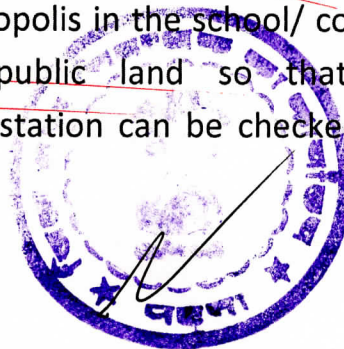

environment can emerge through soci-economic change. For this purpose, different types of fruits, fodder and fuel trees will be planted for the protection and presentation of the environment.

20. To establish drug-de-addiction centers/clinics and research centers to facilitate treatment/nursing of drug-addicted patients and their rehabilitation and to identify the cause /reasons which provoke youth and people to be drug addict and provide them settable treatment.

21. To train the educated women and youth by providing knowledge of cooking art, learning of house decoration, health care & Beauty- Culture, Computer (Hardware & Software) Training & Development, Tourism, Fashion designing and Gardening.

22. To promote programmes for family planning/family welfare and population control through demonstration and operation as prescribed by law.

23. To establish charitable health centers for the welfare of poor and needy people, for this purpose, Allopathic, Ayurvedic, Unanni, Homœopathic, Naturopathy and other systems of medicines will be adopted.

24. To provide information regarding Leprosy, Cancer, AIDS and other infections diseases in urban and rural areas, and to render free medical facilities and guidance to general people.

25. To cultivate the spirit of culture among the people by holding music, drama, dance, concerts, debate, lectures and quiz for the entertainment of the people.

26. To engage for preparation of statutory report for any industry, creating water and air pollution problem and submit the exhaustive report for preparation of treatment as when required under the Pollution Control Act prevailing in the different states and the Government of India.

27. To undertake construction and maintenance or drinking water supply schemes, hand tube-wells and drill tube-wells in urban and rural areas.

35. To undertake, implement/execute and put in action the welfare charitable schemes of Central Government/State Government/Local Bodies or any other institution /institutions/agencies for the benefit of the Trust.
36. To develop a Seva Dal/human chain throughout nation and the world to train and make conscious people at large to associate themselves in natural calamities and removal of human sufferings.
37. To accept donations (in cash or kind), subscriptions, grants, presents and to collect dividends, rents, interests and other income of the TRUST FUND etc, for being utilized to further the objects thereof.
38. To establish Food Processing Training Centers (FPTC) and Food & Fruits Processing Production Units.

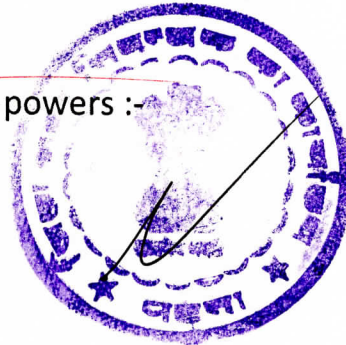
The General Management of the Trust for the purpose of managing the affairs and properties and carrying out the objects of the Trust aforesaid shall be vested in the Board of Trustees. The Board of Trustees shall have one Chairman/Chair Person. The first Chair Person shall be Madhuri Kumari who will hold office of the Chair person for life.

Thereafter the existing Trustees and without prejudice to the generality of the objects and powers above mentioned, they shall have powers to do all or any of the following that is to say :-

- A. To enter into contracts and borrow money from Bank, institutions or individuals for the purpose of the Trust and management or its properties and assets.
- B. To appoint officers and staff at such remunerations, if any, as they think fit.
- C. To appoint consultants for specific purpose on such terms and conditions as they may deem fit.
- D. To enter into agreements with organizations and individuals for execution of any projects that may be undertaken to taken over by the Trust from time to time.
- E. To make rules and regulations from time to time for the management and conduct of the affairs of the Trust and its properties and assets.
- F. The number of trustees shall not be less than three and not more than seven. The Trustees shall be trustees for their life time, but any trustee may resign by giving notice in writing to this co- trustees and shall also oases to be trustee if requested in writing by three-fourth of the remaining trustee or the number nearest there. Appointment of trustees, either to fill up a vacancy or as additional trustee, shall be by resolution of the Trustees.

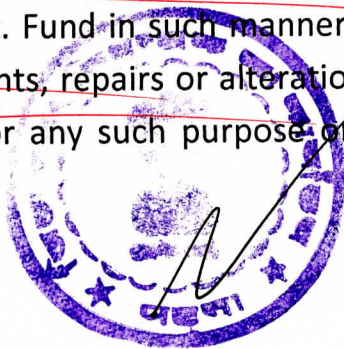

- a. To apply the whole or part of the income or accumulation thereof or whole or part of the corpus of the Trust Properties for one or more of the objectives of the trust as the Trustees may from time to time determine.
- b. To amalgamate the Trust with any other Trust or Charity for wholly public charitable purpose.
- c. To convert and get in the Trust or Charity for wholly public charitable purpose.
- d. To invest and keep invested the Trust properties in the purchase of immovable property or in other assets specified in Section 11 (5) of Income Tax Act, 1961 and to alter, vary and transpose such investment from time to time as the trustees shall in their absolute discretion, thing fit, In any case the funds of the Trust shall not be invested in any of the manner which is not permissible by relevant provisions of Income tax Act, 1961, applicable at any given time.
- e. The Trust committee consisting or Trustees shall have power to sel or assign any movable and immovable property or properties for the time being forming part of the trust fund either together or in parcels and either by public auction or ordinate contract and other with or without any special or other stipulations as to title, evidence or commencement of title or other4wise and to buy in and resent or vary any contract fro sale or to re-sell without being made answerable for the loss occasioned thereby and for the purpose aforesaid or any of them to execute and do all such assurances, acts, deeds and things as they shall think fit and out of the moneys, which shall arise from any sale for the interest and of the Trust or otherwise in or about the exaction of any of the Trust or powers of THESE PRESENTS and shall stand possesses of the residue of the said moneys and also of the rents and profits of the said premises of the unsold part thereof for the time being upon such Trust and subject, to such powers provisions, agreements and declarations as are herein declared, PROVIDED, always that the Trustees shall manage any immovable property or properties for time being forming part of the Trust. Fund in such manner as they shall think fit with full power to make improvements, repairs or alterations of any descriptions and to make or inure any outlay for any such purpose or for the insurance or

 the moneys of the Trust to operate such accounts including overdraft accounts
 and to give instruction to Bank or Post Office and to provide for opening and
 operation of such accounts by one or more constituted attorneys/agents
 appointed by the Trustees.

h. To appoint, constitute attorneys or agents and to delegate to such
 attorneys or agents all or any of the powers vested in them under these presents
 for time to time and remove such attorney or agents and to appoint other or
 others in their place.

i. To make, vary, alter or modify schemes, rules and regulations for carrying
 out objects or the trust and for the managements of the affairs thereof and of
 running any institution in furtherance of the objects of the trust and otherwise for
 giving effect to the objects of the trust.

j. To set apart the whole or part of the income or the corpus or part thereof
 for any of the objects of the Trust.

It shall be lawful for the Trustees to settle and determine all matters of interpretation of THESE PRESENTS well as all matters of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration, management and execution of the Trust and power of these present and any such settlement or determination although the question involved may not have been actually raised SHALL BE VAID , binding and conclusive and shall not be rejected to or reopened upon any ground whatsoever.

The trustees shall be entitled from time to time to appoint with or without remunerations and on such terms and conditions as they may think proper, person or agents and to appoint committees as they may think necessary to function, under the authority and control of the Trustees for carrying out of the Trust of THESE PRESENTS or the management thereof and may within the limits of their own powers invest them with all such powers including to incur all such expenditures as may be necessary for carrying out the objects of the Trust.

q. To raise or borrow moneys required for the purpose of the Trust on mortgage or pledge of the Testate or any part thereof with or without any security and at such rate of interest and on such terms & conditions as the trustees shall think fit.

r. To do such acts and things which, may be incidental and necessary or attain the objectives of the Trust.

6. DUTIES OF THE TRUSTEES:-

a. The Trustees shall be chargeable only for such moneys, stocks, shares and funds that shall actually come into their hands and shall not be answerable or accountable for neglect, default, acts or commission or commissions of the other Trustees nor of any Bankers or other persons with whom the trust properties or any securities may have been deposited or handed over unless caused by their willful neglect or default.

b. All the trustees shall be bound to maintain and defend all such suits and (subject to provision of this deed) to take such other steps as may be reasonable for the preservation of the trust and the assertion or protection of the title.

c. The trustees shall be bound to deal with the trust property as carefully as a man of ordinary prudence to deal with such property if it were their own, an, in the absence of a contract to the contrary, as trustees so dealing shall not be responsible for the loss, destruction or deterioration of the trust property

d. If trustees shall be destructive or permanently injurious to the trust property, the remaining trustees shall be bound to take measures to prevent such act.

e. The trustees shall be bound to keep clear and accurate account of the trust property at all reasonable times.

a. The Trustees will not be entitled to received any remuneration as Trustees but may reimburse themselves of all expenses actually incurred by them in connection with trust or their duties relating thereto.

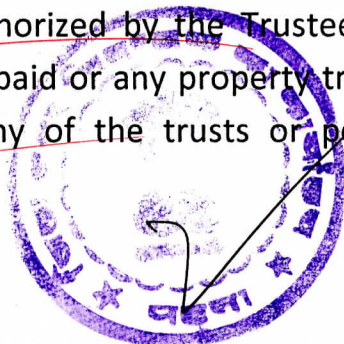
b. The trustee may from time to time associate with the activities of Trust any person or persons or public eminence as patron or patron-in-chief and may appoint or make provision for appointment of committee of committees for conduct of affairs of the Trust for the purpose of administration of any project's or scheme's undertaken by the Trust in consonance with the, objects or the Trust. Appointment of the committee members shall be by the board of Trustees of the committee. The committee shall work under the direct control and supervisions of Board of Trust.

c. The Trustees may from time to time, frame scheme, rules, regulations, laws and bye-laws for regulating the affairs of the projects undertaken by the Trust in pursuance to the various objects. Such rules as framed by the Board of Trustees for the conduct of affairs of the project shall be binding and no deviation shall be permissible in any of the rules so framed by any authority whatsoever connected with the said projects without the prior approval of the Board of Trustees.

d. To Trustees shall have an Advisory Committee of national level to advise the Trustees on the activities of the Trust and to suggest how to make them better serve its aims and objects. The strength of the Advisory committee shall not exceed 50 (fifty) at a given time. The members of the advisory committee shall serve the Trust, in honorary capacity but they may be reimbursed such expense as may be incurred by them for attending the meetings of the Advisory Committee. If so decided by the Trustees.

e. The Advisory Committee appointed by the board of Trustees shall function under the direct control of the Board of Trustees and the Chair Person of the Board of Trustees shall act as ex-officio members of the said advisory Committee.

f. The receipt of person authorized by the Trustees or a resolution of the Board of the Trustees of money paid or any property transferred or delivered to the Trustees in execution of any of the trusts or power thereof or for the

8. INDEMNITY OF TRUSTEES ETC:-

Trustees for the time being or these PRESENTS shall be chargeable for only such moneys, stock, funds, ~~deposits and securities~~ as they shall actually receive not with standing their signing of any receipt, neglects, defaults and not for those, of each other or any Banker, ~~auctioneer or any other person~~ with whom or into whose hands any trust moneys or securities may be deposited or come in accordance with THESE PRESENTS nor for the deterioration or loss of any stock, funds, deposits or securities nor for any defects or insufficiency of title nor for any other losses the same shall happen through their own willful default.

9. RULES OF THE TRUST :-

The Trustees may from time to time frame rules for the conduct of the affairs of the Trust and regulating the meeting of the Trustees in the absences of the regulations.

a. All matters will be decided by majority and two trustees shall form a quorum for meeting of trustees provided however, if the number of Trustees falls below two, than for the purpose of appointing a trustee, one will be a quorum.

b. Resolution passed without any meeting of the Trustees and evidence in writing under the hands of three-fourth of the trustees or the number nearest thereto shall be as valid and effectual as resolution duly passed at the meeting of the trustees.

c. The existing Trustees may appoint one or more, Trustees at their discretion form time to time, but in any case. The total number of the Trustees including the new trustees to be appointed shall not exceed seven. Upon appointment of new trustees jointly with the continuing or surviving trustees powers and subject to this trust.

10. RESTRICTION OF USE OF TRUST FUND AND DISPOSAL OF FUND ON DISSOLUTION.:-

It is expressly declared that no part of the Trust property or its income shall be applied for any purpose which is not a public charitable purpose in law and nothing herein shall be construed to authorized the Trustees to utilize the trust assets or its income for any non-charitable purpose. All the powers and provision hereof shall be constructed as being subject to the restrictions herein contained.

ii. All activities financed from the fund shall be conducted in accordance with the idea's and objects as stated herein and no discrimination shall be permitted therein on grounds of religion, caste, creed or sex, provided that any donations earmarked and accepted for any specific purpose falling within the objects mentioned in THESE PRESENTS shall be used for such specific purpose.

iii. In the event of dissolution of the Trust which may be divided by unanimous resolution of Trustees, the fund held with the Trust on that date, will be donated to any other Trust or institution having similar objects as that of the Trust as determined by the board of Trustees. However no part of the Funds of the Trust will, directly or indirectly be given to either of the Trustees or their relations.

11. ACCOUNTS AND AUDIT :-

The accounts of the Trust shall be closed on 31st March, each year and after the closing, the statement of account in such form as the Board of Trustees may decide or determine will be prepared and thereafter the same shall be presented to the Auditors for report, as the board of Trustees may appoint from year to year, and their remuneration will be decide accordingly in the meeting.

12. MEETING :-

i. The meeting of the Board of Trustees shall be held at least four times in a year more number of meetings may be called if necessary. The meeting may be held at any place in India at discretion of the Chairman/ Chair Person of the Board.

ii. A minute book shall be kept by the trustees wherein entry of all the proceedings of the meetings of the Board of Trustees shall be made which shall

be signed by the Chairman/Chair Person of the meeting either at the conclusion thereof or at the next meeting.

iii. The trustees may if they consider necessary in the interest of Trust to add to delete or amend this declaration of Trust and on which additions, deletion or variation of terms contained in the deed by a resolution of Trustees unanimously, the terms of this declaration shall be deemed to on or variation. In case of difference of opinion arising among the trustees and in all matters where the Trustees shall have the discretionary power, the majority of the Trustees present except as proceed in various foregoing clause, shall prevail and be binding on the majority as well as on those Trustees who may not have noted and if the Trustees are equally divided the matter shall be decided according to the casting vote of the Chairman/Chair Person.

iv. All the power and provisions hereof provided in the Trust Deed shall be construed as being subject to the restriction and limitations herein contained.

13. ACCOUNTS:-

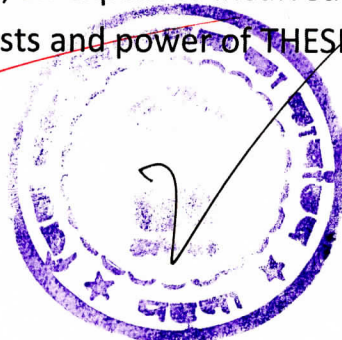
